On 3 November 2023, the Upclose with Budget seminar, jointly organized by K-Konsult Taxation Sdn Bhd and Reanda LLKG International, in collaboration with Alliance Bank, was successfully conducted. The event drew the participation of over 1,000 attendees online.

Remarkably, Upclose with Budget Seminar has been held continuously for 16 years since its inception in 2008, which also marked its first occasion of a Budget seminar conducted entirely in Mandarin. In response to the challenges posed by the pandemic, the seminar shifted to an online format in 2020. However, there are plans to return to a face-to-face seminar next year, aiming to enhance interaction with participants.
