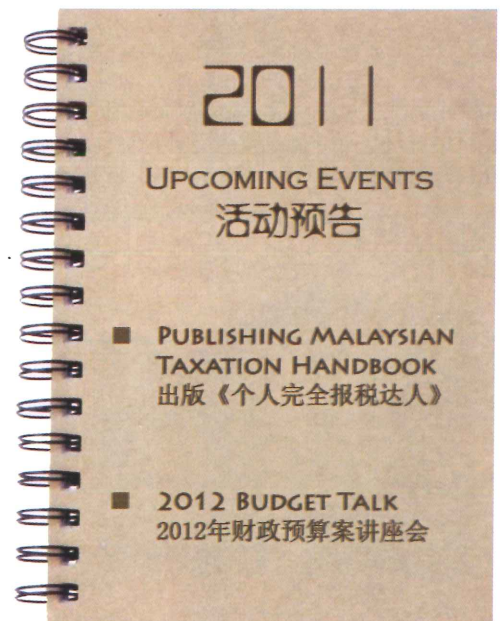
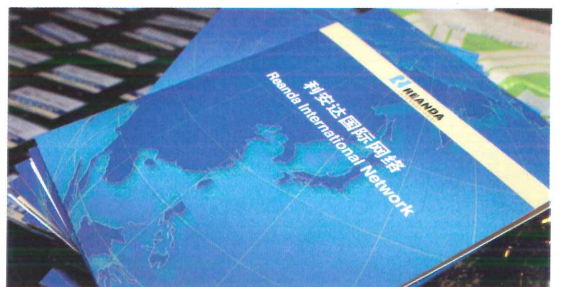

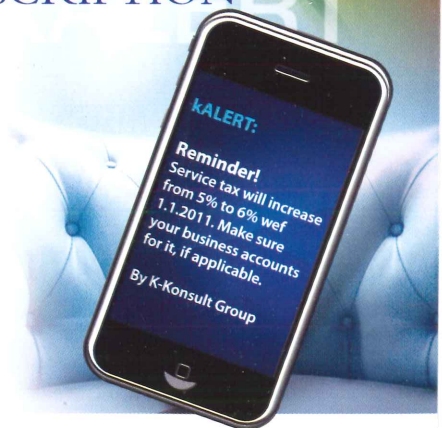

税务调查与税务审核

One of the salient points in our Prime Minister Datuk Seri Najib Tun Razak's 2011 Budget speech is that the federal Government's revenue is estimated to increase 2.3% to RM165.8 billion in 2011, compared to RM161.1 billion in 2010. 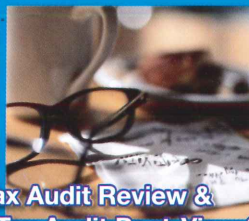
